



## **PLAYER REGISTRATION AND WAIVER**

### Waiver/Exclusion Clause

I, the undersigned parent, guardian, or participant of legal age understand that participation in any XL SPORTS WORLD GA program or any use of XL SPORTS WORLD GA facilities is done at the participant's own risk.

XL SPORTS WORLD GA, its owners, employees, and agents, shall not be liable for any damage whatsoever arising from any personal injury or property loss or damage sustained by participant and family on the premises including parking areas.

Participants, parents, and guardians assume full responsibility for all injuries and damages which may occur in or about any programs on the premises and do hereby fully and forever release, discharge and hold harmless XL SPORTS WORLD GA, and any associated facility and its owners, employees and agents from any and all claims, demands, damages, rights of action, present or future resulting from or arising out of any person's participation in any program or use of its facilities.

### Communicable Diseases

Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF MYSELF AND OTHERS, including, but not limited to, XL employees, volunteers, program participants and their families. I assume full responsibility for myself and/or my child's participation.

On my behalf and on behalf of my child(ren) I willingly agree to comply with the stated and customary terms and conditions for participation as regards to protection against infectious diseases.

I acknowledge the contagious nature of MRSA, influenza, COVID-19 and other infectious diseases and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless XL, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to possible exposure to and illness from infectious diseases.
